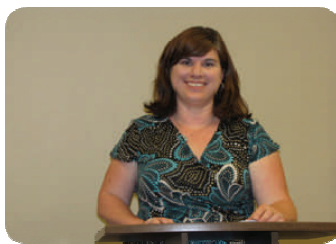

# **New Information From Canada Revenue Agency (CRA) about Registered Disability Savings Plans**

In 2007, the Income Tax Act was amended to require income tax to be withheld at source on payments made from a RDSP. The amount to be withheld must be calculated according to the Income Tax Regulations.

Starting on January 1st, 2014, financial institutions that administer RDSP's will begin withholding income tax at source on the **taxable part** of a beneficiary's RDSP payments using **lump-sum withholding rates**. The withholding requirements will be applied to all beneficiaries who receive or continue to receive payments from a RDSP **on or after January 1st, 2014**. There are no retroactive provisions.

Beneficiaries are more likely to owe tax at the end of the year when they receive large payments from a RDSP. In many instances, income tax withheld at source allows the beneficiary to reduce or eliminate the amount of tax owing when they file their income tax and benefit return.

The taxable part of payments from a RDSP are:

- Canada Disability Savings Grants
- Canada Disability Savings Bonds
- Investment income earned in the plan

Individual contributions are **not** taxable.

The lump-sum withholding rates are as follows:

- 10% (5% for Quebec) on lump-sum amounts up to and including \$5000
- 20% (10% for Quebec) on lump-sum amounts over \$5000 and up to \$15,000 and
- 30% (15% for Quebec) on lump-sum amounts over \$15,000

A financial institution will apply the withholding requirements on RDSP payments as follows:

## **For Lifetime Disability Assistance Payments (LDAP's)**

1. A projection is made of the total of LDAPs expected to be made during the year.
2. The taxable part of the LDAPs is determined.
3. The withholding rate is determined according to the amount of the taxable part of the projected amount.
4. The withholding rate is applied on the taxable part of the LDAP payment, less the yearly basic person amount (BPA) and the disability amount (DA).

## **For Disability Assistance Payments (DAP)**

1. The DAP is determined (withholding is done on every payment).
2. The taxable part of the DAP is determined.
3. The withholding rate is determined according to the amount of the taxable part of the DAP.
4. The withholding rate is applied on the taxable part of the DAP, less the yearly basic personal amount (BPA) and the disability amount (DA).

Note: If a beneficiary receives both LDAP's and DAP's, the withholding rate is determined separately for each type of payment.

Note: Payments made from a RDSP before January 1st, 2014 will not be affected.

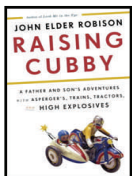
Check out these books that have been recommended by our members.

**Autism in the Family: Caring and Coping Together by Robert Naseef Ph.D.**



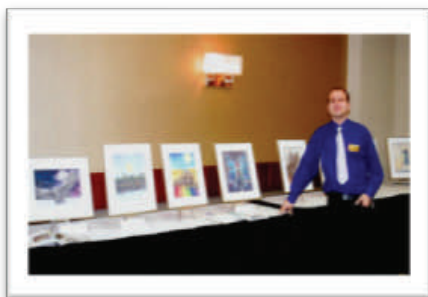
