The Launch into Life curriculum is delivered through a three-week workshop series, which would need a commitment of 2 hours every week for 3 consecutive weeks. This program is designed to help parents effectively assist their young adult child who has Autism or an intellectual disability to create a personalized plan for success as they transition into adulthood.

This program helps parents and young adults explore where they are now, what they want their adult life to look like, and what they require to achieve their goals. To capture a broader picture, the curriculum is divided into 5 domains, which include health and well-being, education and employment, communication and social relationships, independent living skills, self-advocacy, and legal and financial issues.

We also provide train the trainer sessions for those interested in becoming facilitators for Launch into Life with the goal of sharing this curriculum with others across Manitoba. Additionally, if you have previously received this training and would like a refresher, we would be open to offering this type of session if there is enough interest.

Accessible Employment Standard Regulation Review

Every five years, the Accessibility for Manitobans Act calls for a review to ensure the effectiveness of accessibility standards. This regulation focuses specifically on making employment practices more accessible to people with disabilities to ensure that there are equal opportunities in the workforce. The public is invited to share their experiences with accessible employment. This can include what is currently working well and what needs improvement.

The Canada Disability Act (Bill C-22) received Royal Assent and become law on June 22, 2023. The draft of the regulations were released to the public on June 29th, 2024 in Part 1 of the *Canada Gazette*.

Individual Canadians and organizations can review and provide comments on the draft regulations. The consultation period has been extended to September 23, 2024 to ensure that all interested parties have an opportunity to comment. Once the comment period closes, the Government of Canada will analyze the comments receive and revised the regulations as appropriate in response to the feedback.
