# The Closure of the Manitoba Developmental Centre

On December 10<sup>th</sup>, 2024, the last of the residents who lived at the Manitoba Developmental Centre moved into their new home in the community. The official closure of MDC occurred on December 31<sup>st</sup>, 2024.

The closure of MDC is reason for celebration and wouldn't be possible with the advocacy efforts of many, including former residents, such as David Weremy and Valerie Wolbert, families and allies, including Community Living Manitoba and People First of Manitoba and Canada. We are grateful to all who were involved and thank them for their courage and determination.

This important milestone is one of sadness and contemplation as we think about those who lost their lives, experienced trauma and abuse and the end of an era of institutionalization of people with intellectual and developmental disabilities.

It is important to recognize the transition team, the community based organizations and service providers who developed community homes and welcomed and supported residents into their new homes, Community Living Disability Services program staff and also the Manitoba government for fulfilling their promise made back in 2021 to close MDC within three years.

It is fitting that December 10<sup>th</sup> was also Human Rights Day and we recognize and uphold the human rights of people with intellectual and developmental disabilities and their full inclusion and citizenship in community.

#### **New Announcements on the Autism Strategy and Framework**

On September 26, 2024, Canada introduced the *Autism Alliance Strategy* and *Framework for Autism in Canada* to improve the quality of life for individuals with autism and their families. These plans bring together government agencies, healthcare providers, community organizations, and advocates to address service gaps and create more inclusive opportunities.

#### Key Highlights of the Strategy:

- Individualized support plans to meet the specific needs of people with autism in school, work, and healthcare.
- Faster access to services by reducing wait times and connecting families to supports when they
  need them most.
- More resources for caregivers, including training, respite, and support groups to reduce stress and improve well-being.
- Support for young adults transitioning from school to work or independent living.
- Community education to reduce stigma and build understanding through partnerships and awareness campaigns.

#### **Key Priorities of the Framework:**

- Easier access to screening, diagnosis, and autism services.
- Economic inclusion by supporting employment opportunities.
- Improved data collection and research to better understand autism.
- Public awareness to reduce stigma and build acceptance.
- Tools and resources for individuals with autism and their support networks.
